Travel Grant/Registration Fee Exemption for 85th Annual Conference of ISAE (November 11-13, 2025, CCS HAU, Hisar)

The Indian Society of Agricultural Economics (ISAE), Mumbai invites applications for Travel Grants/Registration Fee Exemptions from post-graduate students to attend its 85th Annual Conference, scheduled to be held during November 11-13, 2025, at CCS HAU, Hisar, Haryana.

Travel support will be provided only for train fare, air fare, or bus fare, and not for any local travel or other incidental travel expenditure, and will be limited to a maximum of Rs. 5000. For registration, exemption will be provided up to Rs. 2300. A limited number of travel grants and registration fee exemptions will be available. Those who have availed the travel grant/fee exemption during 2024 are not eligible to apply.

Preference will be given to applicants who:

- Are below 35 years of age
- Have submitted a paper for presentation in the Conference
- Are not receiving financial support from any other source
